Message of National Director for RSETIs, NACER



There has been a steady growth in the Indian economy for the past many years. Though this growth has brought in development across many sectors, there are many challenges, especially in providing gainful employment to the educated unemployed, school dropouts and illiterates among the Rural unemployed youth. The employment potential in the agricultural sector, which is characterized by disguised employment and under-employment, has reached a point of stagnation.

We are grateful that a well-coordinated professional effort to address this problem was made way back in 1982 by Poojya Dr. D Veerendra Heggade, Dharmadhikari of Dharmasthala in Karnataka in association with SyndicateBank and Canara Bank to start Rural Development and Self Employment Training Institutes [RUDSETIs] to provide short term training with long term handholding to the unemployed youth.

It is indeed noteworthy that the training methodology and the best practices followed by **these** RUDSETIs are quite unique and this has resulted in a settlement rate of over 70%. The training methodology and the best practices followed by RUDSET Institutes have been adopted by the Ministry of Rural Development to replicate the same in all the RSETIs. The initiatives of various sponsor Banks in promoting the RSETIs has resulted in functioning of 591 RSETIs including 27 RUDSETIs as on date, providing gainful employment opportunities to many rural unemployed youths.

While the employment opportunity in Government/Public Sector is not increasing much, the growth in employment potential in Private Sector is not keeping pace with the growth in the number of youths seeking employment. With the increasing trend towards consumerism, the opportunities for Self-Employment, particularly in the Services Sector, are increasing by leaps and bounds. But the unemployed youth are not properly oriented towards Self-Employment. Consequently, they are not able to engage themselves in any productive activity and tend to become dejected in life. This is where our 591 RSETIs including 27 RUDSETIs can play a proactive role as Change Agents, orienting the unemployed youth towards entrepreneurship, imparting the required training, and providing escort services to enable them to set up their own ventures.

It is indeed a matter of pride that the RSETIs/RUDSETIs have cumulatively trained 49.4 lakh rural unemployed youth of which 35.6 lakh candidates have been settled up to 31.03.2024 i.e., above 72% settlement. The share of women candidates trained comes to above 68%. Further, the performance during FY 2023-24 is 4.51 lakh (105% achievement) in training, 3.46 lakh (77%) in settlement, and 2.08 Lakh (61%) in credit Linkage. Successful entrepreneurs have not only become self-employed but have also provided employment to a number of people in their ventures. It is noteworthy that RSETIs/RUDSETIs have played a major role in transforming the job seekers into job providers.

I am happy to note that your RUDSETI is bringing out the **Annual Activity Report for FY 2023-24.** I take this opportunity to extend my **congratulations to the Director and Team members of the RUDSETI** for their outstanding achievement **in training, settlement, and Credit linkage.** My gratitude to Poojya Dr. D. BRIEF REPORT OF THE INSTITUTE

A humble beginning made through self employment training during 1982 at Ujire of Dakshina Kannada Dist. Karnataka State RUDSETI is completing a successful journey of 42 years and became a model Institute under the visionary leadership of **Dr. D. Veerendra Heggade**, Hon'ble National President of RUDSET Institutes. With the continuous support and guidance from Canara Bank (and e-SyndicateBank) always instinct us to walk an extra mile and sustain our visibility at par.



Further MoRD, Govt of India has accepted RUDSETI as a replicable training model and as of now there are 591 RSETIs across the country which includes 27 RUDSETIs spread across 17 states in the country. The need for the same is being realized at all levels.

RUDSET Institute, Mysuru was established in the year 1992 since then it is striving hard to bring light into the darkened minds of the unemployed youth of our command area. The Institute is having beautiful campus with very good infrastructure facilities in prime location within Mysuru city limits. We have full pledged staff strength having one Director, Two senior Faculties, Two Office Assistants one Attender and One Watchman cum Gardner.

We conduct regular training programmes approved by National skill qualification Framework (NSQF) broadly under following categories 1. Agricultural EDP, 2. Product EDP, 3. Process EDP, 4. General EDP, 5. Skill upgradation programme for settled entrepreneurs and 6. Any other training programmes based on local needs can be designed and implemented, subject to approval from NSQF and National Academy of RUDSETI. We have conducted **915** training programmes benefitting **29042** candidates since inception.

RUDSETI provides different skill training programmes to the unemployed youth who are in the age group of 18-45 years. RUDSETI provides training programmes for such youth in different skills. The duration of the training programme will range from 6 days to 45 days. All the training programmes are purely residential with free of cost including boarding and lodging facilities. The philosophy of the RUDSETI is to channalise youth power in wealth creation of our nation by taking up a self employment venture.

RUDSET Institute, Mysuru has completed Thirty one Years of successful journey after its beginning in a small house near the footage of Chamundi hills.

We are having a command area of three districts of Karnataka viz., Mysuru, Mandya and Chamarajanagara.

We are happy to inform that we could able to achieve the target fixed to conduct number of programmes for the FY 2023-24. The performance is as follows. Target was **25** programmes with **750** candidates. Achievement is 28 programmes with 789 candidates trained under various self employment training programmes.

Out of the above programmes we have conducted 8 Agri. EDPs, 4 Product EDPs, 13 Process EDPs and 03 General EDPs. Out of the 789 trained candidates 196 trained under Agri. EDPs, 88 are trained under Product EDPs, 412 are trained under Process EDP and 93 under General EDPs.

Post Training Follow up for two years is our unique selling proposition (USP) of RUDSETI training. During this year good number of candidates are settled under various ventures. About 561 candidates settled this year rising our overall settlement rate to 71%. We could conduct 190 number of follow up meetings to cover 2268 candidates.



Rural Development being our main motto, during this year we could cover **724** candidates from rural area, 28 from semi urban sector and 37 from urban sector.

Out of the total participants of 789, around 92% candidates were from rural area, 3% from semi-urban and 5% were from Urban area making it real rural development this year.

Out of the total 789 trained candidates Category wise break-up of candidates as follows, SC-229 (29%), ST-91 (12%), OBC-417 (52%), remaining 7% under Minorities and Other categories. Of the total 789 candidates 717 are from BPL category (91%).

During this year we could conduct able to 110 Entrepreneurship Awareness Programme covering 3864 beneficiaries. We could also conduct 20 Sensitization Programmes covering 688 Bankers, 01 Entrepreneurship Orientation Programmes covering 15, 04 HRD Programmes covering 121 Government officials and 02 Rural Development Programmes covering 75 women beneficiaries.

Looking into the gender wise training participation, of the total number of 789 trained candidates 336 are women candidates (43%), the rest of 453 men (57%). We have conducted 2 DLRAC meetings during this financial year. We are happy to inform that during this year we could conduct 2 innovative / New training programmes under Self Employment.

We have conducted a unique programme of RBI about awareness camp on Financial Literacy Week - 2024 sponsored by RBI in which **110** participants comprising of Students, Teachers, FLCC councilors and Bank Executives. The programme was chaired by LDM, LBO, SBI, Mysuru, DDM, NABARD, Mysuru. The programme has gained wide media publicity.

RUDSETI, Mysuru had installed stalls at "Udyoga Melas" conducted in prominent place of Mysuru city and mobilized 1000 + number of application for different skill training programmes.

We gratefully acknowledge the guidance and support extended by our Ex-Directors and Bankers from time to time.

With insightful guidance, Visionary leadership and immeasurable divine grace of our beloved National President **Paramapoojya Dr. D. Veerendra Heggadeji** and unstinted support from our sponsors: SDME Trust and Canara Bank. We at RUDSETI, Mysuru with sincerity and dedication involved to help the youth of our command area to gain self-reliance, dignity and self-worth.

The Post Training escort service called Follow up is the most distinguishing feature of RUDSETI model of training. It gives maximum importane to this function and spares considerable amount of time to follow up the trainees for a minimum period of two years after the training. It involves meeting the candidates personally within 90 days from the training period this helps the Institute to track the progress of the trainees. The follow up system has been coordinated with various agencies for assisting the trainees in setting up of self employment venture. Follow up helps the trainees to sustain motivation level and set up their projects at their earliest the various modes of follow up are through correspondence, individual contacts, meeting at village, taluk and district levels. During the process, the trainees are provided with valuable suggestions with suitable counseling wherever needed. RUDSETI is the sole training organization which facilitates the credit linkage with the banks and also business linkage for the budding entrepreneurs. During this year Institute has organized 190 follow up meets and met 2268 trainees and recorded their progress through spot visits.
