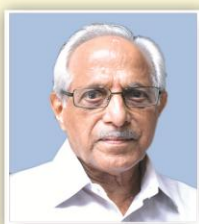

Performance Under Key Indicators

Silli Ranchi is the **27th** branch of RUDSET Institutes in all over India. Here at Silli Ranchi this Institute was started in **June'2011**. Since then, RUDSET Institute, Silli Ranchi have been imparting trainings programmes for both the educated, uneducated and unemployed youth and also motivating them to take up self employment as an alternative career.

This Institute is providing trainings in more than **60** types of vocations for the residents of Silli Ranchi districts. The training programmes are completely residential and free of cost including boarding and lodging.

Since our inception, we have conducted **249** self employment training programmers and trained **7084** unemployed youth. We are successful in motivating **5204** trainees and trained **7084** trainees in EOPs (entrepreneurship orientation programme) to start up their own self employment ventures, servicing for their self employment and for better life In order to mobilize applications from unemployed youth. 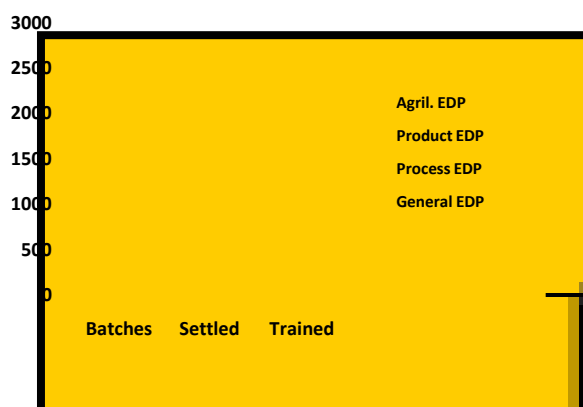
